General Mixing Order Guidelines for Engenia® Herbicide

Mixing Order

Never allow products to mix together prior to adding to the tank.

- 1. Fill sprayer 1/2 to 3/4 full of clean water start agitation
- 2. Add pH buffering adjuvant*, such as AEGOS™ or Sentris™ Buffering Technology, compatibility agent and/or defoamer
- 3. Add Non-DRA containing water conditioner
- 4. Add water dispersible products (WDG, DF, WP)
 - Zidua® WG herbicide
- **5.** Continue agitation
- 6. Add suspension concentrate (SC)
 - Zidua Pro herbicide
 - Zidua SC herbicide
 - Sharpen® herbicide
- 7. Add encapsulated products (CS)
 - Prowl® H2O herbicide
- 8. Add guar-containing DRA or deposition aid products
- 9. Add soluble liquids (SL)
 - Engenia herbicide
 - Glyphosate
- **10.** Add emulsifiable concentrates (EC)
 - Outlook® herbicide
 - Clethodim
- 11. Add NIS/oil-adjuvants
- Add acrylamide-containing DRA or deposition aid products
- 13. Add nutritionals
- **14.** Add remaining quantity of water
- 15. Continue agitation and maintain throughout application

*EVERY application of Engenia herbicide requires the use of an approved pH buffering adjuvant.
